## MINUTES OF SPECIAL MEETING OF BOARD OF DIRECTORS OF WESTPORT FIRE PROTECTION DISTRICT

The Board of Directors ("Board") of WESTPORT FIRE PROTECTION DISTRICT ("District"), held a special meeting on Friday, April 29, 2022, at 5160 S. Carpenter Road, electronic device:

It was reported that notice of the meeting had been duly given and a quorum was present.

Mr. Amador called the meeting to order at 3:30 p.m., and Ms. Nunes was then appointed as recording secretary for the meeting.

Mr. Amador reported that in conjunction with the acquisition of the Hi-Tech Spartan Gladiator Type 1 Pumper fire engine ("Equipment"), the District received a proposal and lease documents from Leasing 2, Inc. ("Leasing 2"), located at 1720 West Cass Street, Tampa, Florida (33606-1230). The total cost of the lease from Leasing 2 is \$292,454.31, bearing interest at the rate of 3.84%, with annual payments of blended principal and interest in the sum of \$48,439.59 with the proposed lease of the Equipment from Leasing 2, the Board reviewed the Lease-of Minutes, Certificate as to Arbitrage, Description of Equipment, Payment Schedule, Qualification (collectively, "Lease Documents").

John Varni then moved, and Stacy Cardoso seconded, to adopt the following resolutions:

RESOLVED, that the District enter into lease financing arrangements with Leasing 2 for acquisition of the Equipment according to the terms and conditions of the Lease Documents; and

RESOLVED FURTHER, that the Lease Documents be and hereby are duly approved by the Board; and

RESOLVED FURTHER, that Ed Amador as Chair and Stacy Cardoso as Secretary, on behalf of the District, be and hereby are duly authorized, empowered, and directed to execute the Lease Documents and deliver them to Leasing 2.

Discussion followed, a vote was taken, and the above motion and resolutions were approved by a vote of four in the affirmative and one (Mr. Hyer) in the negative.

Mr. Amador and Ms. Cardoso then signed the Lease documents.

The meeting was thereupon adjourned at 3:45 p.m.
